

## Mandate for the exercise of GDPR rights

### ARTICLE 1. PURPOSE OF THE MANDATE

The purpose of this mandate is to entrust the agent with the exercise of my right(s) with:

More specifically, the representative may exercise my:

In order to enable TREEZOR to identify me, I understand that it is necessary to provide information that corresponds to the information it holds about me.

I therefore authorise the representative to transmit, if necessary, the following information about me:

- ☐ Information relating to my connection to the organisation's website: date, device used, etc.;

I understand that if TREEZOR has doubts about my identity, it may, in accordance with Article 12 of the GDPR, ask me for additional information by contacting me directly or through the representative.
